BEAR CREEK OUTDOORS ARCHERY RANGE WAIVER/RELEASE

In consideration of being allowed to participate in any way in Bear Creek Outdoors Archery Range events and activities, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from archery and other known and unknown events and activities and/or the use of related buildings, structures, equipment, automobiles, firearms, weapons, ATVs, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by Bear Creek Outdoors, LLC or others is significant including the potential for permanent paralysis and/or death. And while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and

I acknowledge and agree that the use of archery equipment, firearms and other weapons by others or myself on the Bear Creek Outdoors, LLC premises or otherwise are inherently dangerous and high-risk activities whether such archery equipment, firearms or weapons are discharged by others or myself, and
3. I KNOWINGLY AND **FREELY** ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE **NEGLIGENCE** OF THE RELEASEES or others, and assume full responsibility for my participation, and
4. I willingly agree to comply with the stated and customary terms and conditions for participation, if, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
5. I, myself, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS BEAR CREEK OUTDOORS LLC, its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers and if applicable, owners and lessees of real property and personal property used to conduct the events and activities ("RELEASEES") with the respect to any and all injury, disability, death or loss or damage to personal property, whether arising from negligence of the RELEASEES or otherwise to the fullest extent permitted by law.
